The Cannabis Business Tax is imposed on every person engaged in cannabis business within the City of Adelanto as defined in Adelanto Municipal Code (AMC) §3.60.010 Payment of the tax in accordance with AMC §3.60.040 does not authorize the unlawful business. Cannabis Business Tax filings are due on or before the 15th day of the month following the reporting month. In the event the 15th day of the month falls on a weekend or recognized City holiday, the due date shall be the next regular business day of the month.
