NOTICE IS HEREBY GIVEN that a public hearing for the following project will be held before the Adelanto City Council in the City Council Chambers at, **11600 Air Expressway, Adelanto, California 92301, on Wednesday September 9, 2020, at 7:00 p.m. in the City Council Chambers to allow for social distancing and are closed to public attendance.** Only Council members and essential staff are allowed to be physically present, and will be seated the recommended distance from each other. Public participation is solely via call-in or via written correspondence. **TO PARTICIPATE, please call, email, or send mail to the contact info provided below.**

Appeal of Planning Commission decision to approve Conditional Use Permit 96-11 (Modification No. 2): An appeal of Planning Commission decision to approve the proposed modification of condition number 12 to allow housing for Federal inmates and detainees and allow the Desert View Correctional Facility to house male and/or female inmates and detainees. The facility is located at 10450 Rancho Road. Resolution No. P-20-03.

The project qualifies as a Class 1, Existing Facilities Project Exemption pursuant to Section 15301 of the California Environmental Quality Act Guidelines.

On March 12, 2020, Governor Newsom issued Executive Order N-25-20, relating to the convening of public meetings in light of the COVID-19 pandemic. At this time, Adelanto is continuing to hold City Council meetings in order to conduct essential business.
