



Street Address Assignment (SAA)

INSTRUCTIONS TO APPLICANT

The applicant must complete the attached form as prescribed, and all of the following information must be attached before it can be accepted for filing and processing by the Department of Public Works/Engineering. **Note: per Section 13.15.060 of the Adelanto Municipal Code, only buildings, structures or parking lots may be assigned an address in association with a project or permit; vacant parcels will NOT be assigned an address unless in conjunction with an approved city project or permit.**

- a) Application fee of \$50 plus \$0.75 per address over two(2) addresses – Checks should be made payable to City of Adelanto.
- b) Application processing time is Four (4) Business Weeks/Twenty Business Days – Processing time does not include weekends, City Holidays, alternating closed Fridays, or any other day that City Hall is closed.
- c) Plot Plan – Two (2) copies of a precise grading plan or plot plan shall be submitted (along with an 8 ½” x 11” reproducible copy), shall be drawn neatly and accurately to scale (not smaller than 1 inch equals 100 feet), and shall show the following data:
 1. All property boundaries and abutting streets;
 2. All existing and proposed buildings, structures, fences, walls, driveways, and parking areas showing number and location of parking spaces and proposed Landscape and Lighting Maintenance District water and power pedestals;
 3. Nearest location of intersection of Major Streets.
 4. Directional arrows upon structures indicating which street the structure fronts upon.
- d) Copy of the Grant Deed for the subject property, or a Title Report (dated within 60 days of the submittal of the application). If the applicant is other than the owner of record, an affidavit signed by the owner that designates the applicant as an agent must accompany the application.
- e) Copy of digital data. The applicant must provide a digital AutoCAD file of the precise grading plan/plot plan. Plans must show structures being addressed, all driveways, all property lines, and proposed Landscape and Lighting Maintenance District power and water pedestals.
- f) Responsibility to Install. Five (5) Business days after notice of Street Address Assignment the applicant shall install and provide proof of installation, such as a photograph, of Assigned Street Addresses upon the Building or Structure project site.
